#### **Course Overview:**

What is international law? Is it really law? Do treaties, customs, general principles, international court rulings, the declarations and resolutions of international organizations, scholarly writing, and international norms really matter to rational, self-interested states and individuals in the absence of an overarching governing authority? Can international law limit state jurisdiction? Why do states comply with international law? The first part of this course will explore the foundations of international law. By providing students with a comprehensive understanding of the theories, history, sources, actors, and processes of creating international law, they will be able to begin to answer these questions.

The second part of the course will extend these foundations to the intersection of domestic and international law, and then apply them to five key issues areas: human rights, laws of the sea, the environment, international crimes, and the use of force. In doing so, students will begin to compare areas in which the international law may be more or less effective in shaping interactions among states and individuals. As international law is also offered in many law schools, it should be noted that this course will focus exclusively on public international law and will be presented from an international relations perspective.

#### **Course Goals:**

- 1. Comprehend the basic principles, practices, and instruments of international law.
- 2. Evaluate the strengths and weaknesses of the international law process.
- 3. Assess the effectiveness of international law in today's global system.
- 4. Articulate clear and evidenced-based arguments while acknowledging applicable counterarguments.
- 5. Cooperate and communicate with one another to share knowledge and expertise.
- 6. Recognize where the course material fits into scholarly dialogue and analyze strengths/weaknesses within an argument.
- 7. Identify applicability of course material to personal interests and real-world events.

## **Required Materials:**

## **Chapter Summaries: 20%**

For each day there is a chapter of reading assigned, there is a Chapter Summary due by midnight the night before. These should include a 300-500 word summary of the core concepts and/or key debate outlined in the reading, a short explanation of how the chapter relates to previous course material, and 3-5 discussion questions. Students must complete 4 of the 6 options prior to the midterm exam, and 6 of the 8 options after the midterm exam. For more details and advice, refer to the handout on Canvas. Late work will be accepted for half credit until noon after the deadline.

## **Explanatory Article: 20%**

The large individual project for the class will be the development of an explanatory article. Students will select a current international treaty to write a 1000-1200 word article. The grade will be composed of participation in these workshops on components – proposed topic, outline, full draft, and final submission. For more information, refer to the handouts on Canvas.

# Treaty Project: 20%

The large group project for the class will be the drafting of a treaty. This simulation will provide you with the opportunity to apply key concepts from the course. This is a team project that will include a collective activity, individual submissions, and routine peer evaluations of each member of your group.

You will be graded on the quality of the team submission and your individual contributions. *Italicized* items will be graded individually. **Bold** items will be graded as a team. For more information on each component, refer to the handouts on Canvas. Self & Peer Evaluations will not affect Treaty Project grades. Any deductions will be taken from Participation Points.

#### Exams: 15% Each

Exam material will be drawn from assigned readings, class discussion, any movies shown in class, and any other supplementary materials. The multiple choice will evaluate mainly definitional knowledge. The essays will evaluate argumentation, broader theoretical understanding, and the ability to formulate and express an informed opinion. The final exam will be cumulative.

## **Attendance & Participation: 10%**

Attendance: Attendance will be taken at the beginning of class each day.

<u>Excused Absence:</u> Excused absences are considered to be: (1) because of participation in University-sanctioned activities and programs, (2) because of personal illness, or (3) because of compelling family and/or other circumstances. You must provide written documentation verifying that your absence is due to one of these factors no later than one week after the class period in question.

<u>Unexcused Absence</u>: You have three (3) unexcused absences to use whenever necessary. I do not need to know the cause of these. After three unexcused absences, each unexcused absence will result in a deduction of 2 percent from your final grade. No more than ten percent (10%) of your grade will be deducted based on absences.

*Participation*: Attendance is a necessary but not sufficient condition for class participation. Participation should include meaningful contributions to the overall quality of the class. Participation will be graded out of 10 points. Any deductions for absences will be deducted from your participation point total.
